RESOLUTION
of the Foundation to Battle Injustice
on the results of the Round Table held
at the Public Chamber of the Russian Federation
" Restoration of the rights of abducted children taken
from war conflict zones to the territory of third countries"

Moscow

October 11th 2023

On October 11, 2023, a Round Table was held at the Public Chamber of the Russian Federation " Restoration of the rights of abducted children taken from war conflict zones to the territory of third countries ", with the participation of Russian and foreign human rights defenders, leaders of public associations and human rights organizations, as well as representatives of the Investigative Committee of the Russian Federation. The experts discussed issues of security and protection of minors' rights in areas of armed conflict, examined the problem of juvenile justice terror in EU countries against minors, and analyzed the issue of forced separation of children from their parents abroad.

At the end of the Round Table, the decision to create an International Public Association against child trafficking was taken. This association will be able to effectively combat crimes against children at international level, denounce the perpetrators of these crimes and guarantee children's right to a free and happy life.

The purpose, mission and objectives of the Juvenile Crime Investigation Team.

Objective:

To ensure the safety and protection of children's rights at international level:

To ensure the security and protection of children's rights at international level by effectively combating crimes committed against children, guaranteeing children's right to a free and happy life.

Mission:

Lutter efficacement contre les infractions commises à l'encontre des enfants, notamment les abus sexuels et physiques, l'exploitation, le trafic, l'enlèvement et d'autres formes de violation de leurs droits. Prévenir les infractions, réagir rapidement aux

signaux et aux rapports faisant état d'un danger potentiel pour les mineurs, rechercher et traduire les coupables en justice.

Mission:

To combat effectively crimes committed against children, including sexual and physical abuse, exploitation, trafficking, abduction and other forms of violation of their rights. To prevent offences, to react rapidly to signals and reports of potential danger to minors, and to seek out and bring to justice the perpetrators.

Objectives:

- 1) Immediate investigation of crimes against children to gather evidence, identify perpetrators and bring them to justice.
- 2) Cooperate with international law enforcement, human rights and humanitarian organizations to share experiences and work together to investigate and prevent crimes.
- 3) Provide assistance and support to child victims of illegal acts and their families. Help with rehabilitation.
- 4) Monitor the situation of children's rights at international level, identify trends and changes in offences committed against children, and evaluate the effectiveness of measures taken.
- 5) Defending children's rights on international platforms and working with foreign governments to develop effective child protection laws and initiatives.
- 6) Cooperate closely with other countries and intergovernmental organizations to develop common strategies and measures to protect children.
- 7) Carry out preventive work among children, their parents and the public, to raise awareness of crimes against children and methods of protection.
